### For what purpose, and on what basis, do we process personal data?

John & Marine van Vlissingen Art Foundation processes your personal data for the following purposes:

### Automated decision-making

John & Marine van Vlissingen Art Foundation does not make decisions on matters significantly affecting individuals based on automated processes. These encompass decisions taken by computer programs or systems, without the involvement/presence of a person (i.e. an employee of the John & Marine Van Vlissingen Art Foundation).

### How long is your data stored?

John & Marine van Vlissingen Art Foundation does not store your personal data longer than is strictly necessary to achieve the process for which your data was originally collected. We use a retention period of up to three years for the data provided to us through e-mail or regular mail. This, unless a legal obligation requires us to keep the relevant information for a longer period of time.

### Sharing personal data with third parties

John & Marine van Vlissingen Art Foundation only provides information to third parties if this is necessary for the carrying out of our objective, or in order to comply with a legal obligation.

**Cookies, or similar techniques, that we use**

John & Marine van Vlissingen Art Foundation does not make use of cookies or similar techniques.

**View, modify or delete data**

You have the right to view, correct or delete your personal data. Additionally, you have the right to withdraw your consent to the processing of data, to object to the processing of your personal data by the John & Marine van Vlissingen Art Foundation, and the right to data portability. This means that you can submit a request, asking us to send the personal data (collected and stored by us) to you or to another organization indicated by you.

To ensure that the request for access has been made by you, we ask you to provide a copy of your identity document alongside the request. Please remember to black out the MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) in this copy. This is to protect your privacy. We will respond to your request as soon as possible, with a maximum response time of four weeks .
